At Vinapse, accessible from <https://vinapse.io>, one of our main priorities is the privacy of our visitors. This Privacy Policy document contains types of information that is collected and recorded by Vinapse and how we use it.

This Privacy Policy applies only to our online activities and is valid for visitors to our website with regards to the information that they shared and/or collect in Vinapse. This policy is not applicable to any information collected offline or via channels other than this website.

Consent

By using our website, you hereby consent to our Privacy Policy and agree to its terms.

Information we collect

The personal information that you are asked to provide, and the reasons why you are asked to provide it, will be made clear to you at the point we ask you to provide your personal information.

If you contact us directly, we may receive additional information about you such as your name, email address, phone number, the contents of the message and/or attachments you may send us, and any other information you may choose to provide.

When you sign in to our website using an external authentication system, such as Google and Microsoft, we may collect your contact information. Specifically:

- Name
- Surname
- Organization name
- List of course enrolments
- E-mail address

We may also collect information related to your use of the website:

- Items watched
- Annotations
- Interactions with the features

How we use your information

We use the information we collect in various ways, including to:

- Provide, operate, and maintain our website
- Improve, personalize, and expand our website
- Understand and analyze how you use our website
- Develop new products, services, features, and functionality

- Communicate with you, either directly or through one of our partners, including for customer service, to provide you with updates and other information relating to the website, and for marketing and promotional purposes
- Send you emails
- Find and prevent fraud

Log Files

Vinapse follows a standard procedure of using log files. These files log visitors when they visit websites. All hosting companies do this and a part of hosting services' analytics. The information collected by log files include internet protocol (IP) addresses, browser type, Internet Service Provider (ISP), date and time stamp, referring/exit pages, and possibly the number of clicks. The purpose of the information is for analyzing trends, administering the site, tracking users' movement on the website, and gathering demographic information.

Cookies and Web Beacons

Like any other website, Vinapse uses 'cookies'. These cookies are used to store information including visitors' preferences. The information is used to optimize the users' experience by customizing our web page content based on visitors' browser type and/or other information.

Third Party Privacy Policies

Personal data will be communicated also to other entities, which, as part of the provision of services necessary in pursuit of the above-mentioned purposes, may have to process the personal data of the data subject(s) on behalf of the Data Controller. To this end, the subjects managing the above-mentioned platforms have been designated Data Processors. Personal data may be subject to transfer to countries outside the EU; in this case, the transfer will be made on the basis of an adequacy decision pursuant to Art. 45 GDPR or, in its absence, the standard data protection clauses pursuant to Art. 46(2)(c) GDPR.

Outside of these cases, data may be disclosed to third parties only for the fulfillment of a legal obligation and/or an order of a judicial authority.

CCPA Privacy Rights (Do Not Sell My Personal Information)

Under the CCPA, among other rights, California consumers have the right to:

Request that a business that collects a consumer's personal data disclose the categories and specific pieces of personal data that a business has collected about consumers.

Request that a business delete any personal data about the consumer that a business has collected.

Request that a business that sells a consumer's personal data, not sell the consumer's personal data.

GDPR Data Protection Rights

We would like to make sure you are fully aware of all of your data protection rights. Every user is entitled to the following:

The right to access – You have the right to request copies of your personal data. We may charge you a small fee for this service.

The right to rectification – You have the right to request that we correct any information you believe is inaccurate. You also have the right to request that we complete the information you believe is incomplete.

The right to erasure – You have the right to request that we erase your personal data, under certain conditions.

The right to restrict processing – You have the right to request that we restrict the processing of your personal data, under certain conditions.

The right to object to processing – You have the right to object to our processing of your personal data, under certain conditions.

The right to data portability – You have the right to request that we transfer the data that we have collected to another organization, or directly to you, under certain conditions.
